Vendor Booth Offerings

Registration. All booths are \$350 and the booth size is 10' x 8'. You may purchase more than one booth (at \$350 per booth) to increase the amount of space you need to showcase your business with an addition deposit of \$100 per booth space. If you require outside space, please contact David Moore at (719) 239-0085 for more information.

To secure your booth location, you can pay in full or submit a **\$100 deposit per booth** and a signed contract. The remaining amount is due March 29, 2018. If the remainder of the payment is not received on time, this contract will be voided and the space resold to another vendor.

If you would like to be listed in the Show Program, which is circulated in *The Mountain Mail* one week prior to the show to Chaffee County residents and is also distributed to all show participants, you must be paid in full by March 29, 2018.

Any booths purchased after March 29, 2018 will be required to pay total booth amount at the time of reservation.

No booth will be held without a confirmed deposit or full payment and a signed contract.

Vendor Education Seminar or “How-To” Demonstration

Educational Seminar: This year, the Chaffee Home & Garden Show will have 45 minute presentations/seminars available to the public on Saturday, April 28th. This provides the vendor an opportunity to educate participants to newest gardening or home improvement techniques. Each presentation will allow for up to 35 participants in a classroom style setting providing presenters with access to a wall-mounted TV monitor display (you need to provide your own computer). The presentation room also allows for cooking demonstrations. **As the educational seminars are available for one day, only a few sessions are open to vendors; therefore, final decisions of participants will be made by the Chaffee Home & Garden Committee.**

“How-To” Demonstrations: We will also provide an opportunity for Vendors to have a 15 minute public demonstration area for up to 15 individuals. This area does not provide running water and only a 3’x8’ table will be provided with no guarantee of electricity. These demonstration sessions will be scheduled on a first-come basis.

GENERAL VENDOR INFORMATION

PLEASE NOTE THE FOLLOWING:

No gas heaters or open flames are permitted inside the exhibit hall

The Chaffee Home and Garden show will be held in all weather conditions.

RULES AND REGULATIONS FOR BOOTHS

1. SET UP: All Vendors must set up Friday April 27, 2018 from 3:00-7:00 pm.
2. TAKE-DOWN: Booths must be dismantled Sunday starting at 4:00 PM when show closes and should be completed by 6:00 PM.
3. BOOTH SPACE: No signs or display materials may protrude beyond the boundaries of the rented display area. All Vendor activities must be restricted to the rented space unless permission has been granted by Chaffee Home & Garden committee. No damage of any nature may be done to the premises. Vendors will be held responsible for any damages. Use of sound equipment, such as microphones, televisions, and DVD players will be permitted where appropriate to the display, provided sound is maintained at conversational level. The Chaffee Home and Garden committee reserves the right to restrict Vendor's use of sound and other devices. No vendor announcements will be made on the exhibit hall sound system.
4. BOOTH STAFFING: Exhibit booths must be staffed during show hours, unless otherwise agreed in writing by the Chaffee Home and Garden committee. If your booth is not staffed, the space may be given to another vendor or a non-profit organization.
5. INDEMNIFICATION BY VENDOR: Vendor agrees to hold Salida Sunrise Rotary Charitable Fund, Inc. and Chaffee Home & Garden Committee harmless from any liabilities incurred directly or indirectly by the Vendor in any manner whatsoever involved this application agreement. Further, Salida Sunrise Rotary Charitable Fund, Inc. and Chaffee Home and Garden Committee shall not be held liable to Vendor for any damages whatsoever or loss of any kind to their Exhibit or Products.
6. LICENSES/PERMITS: Vendor shall be responsible for obtaining any license, permits, taxes or approvals required under local or state law applicable to their activity at show.
7. SUBLETTING/SHARING BOOTH SPACE: Subletting of contract exhibit space is **NOT** permitted. Special arrangements must be made with the Chaffee Home and Garden committee in advance for two or more Vendors to share the same booth.
8. SHOW CANCELLATION: Should any event prevent the Salida Sunrise Rotary Charitable Fund, Inc. from holding the show, it will not be held liable for any expenses incurred by the Vendor other than the rental cost of exhibit space.
9. VENDOR CANCELLATION: If vendor must cancel its booth for good and sufficient reasons and written notice for such cancellation is delivered to Salida Sunrise Rotary Charitable Fund, Inc. by April 1, 2018, Vendor shall receive a refund of any booth fees paid except for \$100 which will be considered a tax deductible donation to the Salida Sunrise Rotary Charitable Fund, Inc. If cancellation occurs after April 1, 2018 all booth fees will be kept as a donation.
10. VENDOR DIVERSITY: Salida Sunrise Rotary Charitable Fund, Inc. reserves the rights to limit number of vendors to ensure broad diversity amongst the vendors.
